



Mr. Dodridge D. Miller, FCCA, MBA, LLM has been the President and Chief Executive Officer of Sagicor Financial Corporation (Formerly the Mutual Group of Companies) since July 1, 2002. Mr. Miller serves as Chief Executive Officer and Acting President of Sagicor Life Insurance Company. He is responsible for the strategic management of Sagicor Group, including international business development, and recently led its successful listing efforts on the London Stock Exchange.

He served several positions at The Mutual Group of Companies, now the Sagicor Group of Companies. He served as a Treasurer, Vice President of Finance and Investments, Deputy Chief Executive Officer and Chief Operating Officer. Mr. Miller joined the Sagicor Group in 1989. He has more than 25 years' experience in the insurance and financial services industries, spanning auditing, accounting, banking, investments and insurance. Mr. Miller spearheaded a number of strategic initiatives within the Sagicor Group, such as the establishment of The Mutual Bank of the Caribbean and CariCard Services Inc. and led the Sagicor Group's re-entry into Jamaica along with the development of Sagicor's international business portfolio. He serves as the Chairman of the Island Life Insurance Company Limited (Jamaica), Sagicor Life Insurance Company and Sagicor Life Inc. Mr. Miller serves as the Chairman of Sagicor General, Capital International Management Services Inc., Allnation Insurance Company (USA) and Capital deSerguros (Panama). He serves as the Chairman of Sagicor USA and Sagicor at Lloyd's. He served as Chairman of Sagicor Life Jamaica Ltd. (alternate name, Life of Jamaica Limited) until January 31, 2010.

Mr. Miller has been a Director of Sagicor Financial Corp. since December 2002. He has been a Director of Pan-Caribbean Financial Services Ltd. since February 7, 2005, Famguard Corporation Ltd. since 2005 and Sagicor Life Inc. since 2001. He has been a Director of Sagicor Life Jamaica Ltd. since 2001. He serves as a Director of Sagicor Life Insurance Company, subsidiaries of Sagicor Financial Corp. He serves as a Director of Cable & Wireless (Barbados) Limited. Mr. Miller serves as a Member of Council of University of the West Indies - Cave Hill.

Mr. Miller is a Fellow of the Association of Chartered Certified Accountants (United Kingdom). In October 2008, he was conferred with an Honorary Doctor of Laws degree by the University of the West Indies.
